NEW BUSINESS:

- Frequency of meetings was talked about, but 1 a month continues to be the favorable option.
 - M.A. mentioned that the staff needs our decisions on important topics and that a meeting once a meeting is the best option.
 - o Dave- Moving to fewer meetings would not be a positive move
 - Stan- Mentioned the option of using phones or skype for people who live far away and cannot drive all the way into Roseburg
 - Richard- We would lose momentum as a board with less meetings
 - o Jan- Grant cycles need to be approved and monthly meetings needed to do this

- o Paul- Mentioned the possibility of having a partial vote when there are not enough board members
- o Nancy- Mentioned having presentations at every other meeting to speed up the process
- Diane- Likes the presentations and this one of the many reasons she comes to the meetings
- Paul- Do board members have to be present or can they vote without being here?
- Executive Director at large was discussed and is voted on by membership in June and cannot be someone from a specific category (i.e. agriculture or timber, etc.)
 - Jan- Voted for M.A. for executive at large
- Rich G.- Mentioned that he is looking for someone from education to fill a spot
- M.A.- wants bylaws changed because she was told that she had the director's position from others then was told later on that she didn't. There is confusion on which bylaws we are following.
- Stan- Envisioned alternate as a transitional position just to fill in when needed
- Paul- Can't vote on anything today because there were not enough board members present. He mentioned it's a lot of work to change the bylaws and would involve a lawyer in the process.
- Richard C.- Mentioned he has no problem with the bylaws and has actively recruited new people and sees the importance in having new members for new ideas.
- Jake- Asked whether anyone can nominate and was answered with it being a formal procedure

PRESENTATION(S):

- Jeff McEnroe, Fish Ranger, Roseburg District BLM. Jeff gave the Council an update on the Wolf Creek Project, past, present and future. The presentation included an overview of past project work and monitoring efforts, what is going on this year, and discussed future research efforts. This project has been gaining momentum for years within the basin and is now receiving some recognition throughout the state.
 - There has been 13 miles of stream restored within the Wolf Cr. Basin and 2 culverts have been
 - Impacts to Wolf Cr. Include riparian road building, forest timber and splash daming
 - In 2008 to 2009 there was log placement and boulder placement; in 2011 there was helicopter log
 - 2013 there will be log felling to fill in gaps in existing jams
 - There was an increase in overwinter survival of juveniles in Wolf Cr.
 - Stan- Asked what the beaver ecology was in Little Wolf
 - Jeff- Stated that there is some activity but beaver do not stay long in the area
 - Jim- Asked how much of the basin has needed restoration
 - Jeff- Stated that 50%needed restoration and of that 70-80% has been accomplished
 - Jake- Asked of the 80-90% of restoration accomplished, what constitutes being done? Will this sustain
 - Jeff- Looking to use AREMP data to determine ending point of the restoration process
 - Paul- Are macro's looked at, are we creating food resources. What about summer survival?
 - Jeff- 33 sites are sampled for Macro's and amphibians every 5 years. The tree felling would be small scale and have a small impact. He mentioned that summer survival of juveniles is hard to determine.
- Jake Winn introduced the new BLM District Manger, Katrina Symons. Katrina gave a brief overview of her background, education and previous experience. She is looking forward to maintaining and growing the relationship the BLM has with PUR and was open to questions and comments from the board.
