#### **UNFINISHED BUSINESS:**

Eric talked about the Elk Creek project, he did meet with our attorney and we have moved forward with the project. We have received the permits, and signed the contracts and the in-stream work is to begin this week.

# **NEW BUSINESS:** Summer 2012 Update Eric Riley

- We had a wet spring so getting logs into the stream was late this year, hard to get the logs needed, we also put in more boulders this year than we usually do. Due to the late start, more had to get done in a shorter period of time. Eric tired to spend more of his time working in the office on permits and such and let the project managers work in the field.
- Accomplishments; we completed 10 projects this summer. Weatherly Creek had 1600 boulders, 75 root wads, 60 logs and 93 tops. Brush Creek had 42 sites, 500 logs and 300 boulders. Scholfield Creek had 2 bridge crossings and wet land work. Big and Sagabeard had 2 culvert replacements. We also worked in S. Myrtle, Jackson Creek, Wolf Creek, Waggoner Creek, Deadman Creek, and Deer Creek.
- Monitoring update, Kris and Joe worked like crazy this summer and did a great job! Sandy spent the summer working on a massive report for OWEB. Sandy is now looking forward to future monitoring efforts and wondering "What's next?"

# PRESENTATION(S): Eric Riley,

- Eric gave an update on Oct OWEB grants, we are putting in for 7 grants. Brush Creek Ph2, Camp Creek, Rock Creek, TA S. Umpqua, Restoration, Monitoring in S. Umpqua Basin, Education, Stream Flow Monitoring which in done with the Water Master Dave Williams.
- Eric also gave a forecasted list for the 2013 summer season. There are 11 potential projects and he would really like to start looking into some larger projects.

Nancy also talked briefly about Salmon schools; she is working with Elkton School who are gathering data for math and statistics classes and Phoenix School who are gathering data for science class. Nancy mentioned that she is discovering that PUR needs to spend more time on our Facebook page and make it better, the community is not responding to it as well as they should be. There was also some discussion on creating a public viewing area on Deer Creek in Dixonville. Diane Phillips Motioned that PUR purchase a tent, not to exceed \$250.00, for Nancy to use when at events such as the Famer's Market, M.A. Hansen 2<sup>nd</sup> the motion and the motion passed.
